

General terms and conditions

These General Terms and Conditions are a translation of the German version of the General Terms and Conditions **"AGB, Widerrufsrecht"**.

1. Goods offered and prices

This website offers posters as well as books and magazines on the subject of posters, advertising and publicity (hereinafter referred to as goods or commodity) from the period from approx. 1880 to 2000.

The goods are used.

The commodity is present in each case only in one copy.

The price of the goods is shown always to the right of the description below the photo of the goods in the following form from left to right: goods number, hyphen, currency Euro, price.

(example: "172 - Euro 210,-" - here the price is 210,00 Euro)

The price of the goods is indicated in Euro and includes the legal value added tax.

The goods are delivered to the following countries: Germany, Switzerland, EU countries, Norway, Israel, Canada, USA, Australia.

For buyers from the non-EU countries Switzerland, Norway, Israel, Canada, USA, Australia the prices are net prices.

When shipping to the non-EU countries Switzerland, Norway, Israel, Canada, USA, Australia taxes and customs fees may apply for the buyer.

The [[shipping costs](#)] to be paid by the buyer.

Goods that have already been sold are marked "verkauft/sold" to the right of the description below the photo or "sold" instead of the photo.

Since the goods are only available in one copy at a time, it can happen in rare cases that the goods have already been sold, although not described as "verkauft/sold" or "sold".

3. Conclusion of contract

Please tell me (supplier of the goods) beside your name and your address the number of the goods you want to buy and which is not marked "verkauft/sold" or "sold" to the right of the description as well as a short title description by e-mail, FAX or telephone. Instead of the number of the goods and a short description of the title you can also tell me the "code" number which is noted at the end of each description of the goods.

If I am not directly reachable by phone and you leave me a voice message or send me an e-mail, I will inform you within 48 hours by e-mail, FAX or telephone about the availability of the goods, as in rare cases it can happen that the goods have already been sold despite price quotation.

If the goods are available, I will tell you the total price of the goods (price of the goods plus shipping costs).

The purchase contract for the goods will be concluded if you accept this offer by e-mail, fax or telephone. You have the right to withdraw from this contract. You can find the relevant "Right of Withdrawal" PDF on the website: www.plakatkontor.de/terms-withdrawal.html

4. Payment

Bank transfer

Payment in advance: For new customers, I reserve the right to make a delivery after receipt of the invoice amount by bank transfer.

Purchase on account: For purchase on account, the amount is due without deduction on the date stated on the invoice (14 days after the invoice date).

5. Delivery period

Delivery period within Germany (Shipment by DHL-Parcel, Standard):

Delivery period for purchase on account: The delivery period is up to 7 days and begins with the day after conclusion of the contract.

Delivery period for payment in advance: The delivery period is up to 7 days and begins on the day following the day the transfer order was placed with the bank.

Delivery period within the EU (with the exception of Germany) and to Switzerland, Norway, Israel (Shipment by DHL-Parcel, Standard):

Delivery period for purchase on account: The delivery period is up to 14 days and begins with the day after conclusion of the contract.

Delivery period for payment in advance: The delivery period is up to 14 days and begins on the day following the day the transfer order was placed with the bank.

Delivery period to the USA, Canada, Australia (Shipment by DHL-Parcel, Standard):

Delivery period for purchase on account: The delivery period is up to 28 days and begins on the day after conclusion of the contract.

Delivery period for payment in advance: The delivery period is up to 28 days and begins on the day following the day the transfer order was placed with the bank.

6. Personal collection of the goods

You can pick up goods personally in Berlin after previous appointment arrangement.

7. Warranty and Liability

7.1 The posters sold are historical originals with unique character. Age- and use-related signs of wear that correspond to the item's age, material properties or customary storage practices do not constitute defects. This includes, in particular, minor paper breaks, creases, edge lesions, discoloration, patina, archival or mounting marks, as well as other age-related changes.

7.2 A defect exists only if the actual condition deviates materially from the agreed condition or if damage is present that exceeds the typical and expected signs of age.

7.3 As the items are unique originals, supplementary performance by way of replacement delivery is excluded. Supplementary performance by way of repair shall only be provided where it is objectively possible and reasonable for the Seller. In all other respects, the statutory warranty rights apply, in particular reduction and rescission.

7.4 The Seller shall be liable for damages only to the extent that such damages result from an intentional or grossly negligent breach of duty. In the event of slight negligence, the Seller shall be liable solely for the breach of essential contractual obligations, and such liability shall be limited to the typical and foreseeable damage arising under the contract.

Essential contractual obligations include, for example, the obligation to deliver the goods, the obligation to hand them over in the agreed condition, the obligation to transfer title, and the Buyer's obligation to pay the purchase price.

7.5 In the event of loss or damage to the unique item caused by slight negligence, the Seller's liability shall be limited to the amount of the purchase price.

7.6 The limitations of liability do not apply to damages resulting from injury to life, body or health, nor to claims under the Product Liability Act.

7.7 Where the Buyer is a consumer, mandatory consumer protection provisions remain unaffected.
